One Member from Himachal Pradesh is to be elected from amongst the persons enrolled in the State Medical Register maintained by the Registrar, Himachal Pradesh Medical Council, who possess the Medical qualifications included in the First or the Second Schedule or in Part-II of the Third Schedule to represent Himachal Pradesh in the Medical Council of India as required under Clause (C) of Section 3(1) of the Indian Medical Council of Act 1956. In order to conduct election for the above, schedule of election shall be notified separately in the official Gazette, two leading News papers (Hindi & English), websites of the Himachal Pradesh Medical Council, Directorate of Medical Education & Research, Himachal Pradesh, Directorate of Health Services, Himachal Pradesh, Indira Gandhi Medical College etc and on the notice boards of the above offices.

**Notice of Election  
(See Indian Medical Council Rules, 1957)**


**Notice is hereby given that:-**

1. An election is to be held to elect one member registered/ enrolled under "State Medical Register" maintained by the Himachal Pradesh Medical Council to represent Himachal Pradesh in the Medical Council of India as required under Clause (C) of Section 3(1) of the Indian Medical Council of Act 1956.
  2. All persons whose names are borne on the State Medical Register and possess the medical qualifications included in the First or the Second Schedule or in Part-II of the Third Schedule to the Act will be entitled to vote at the election of a member under Section 3(1) (C) of the Act ibid and to stand as candidates for such election (see rule 6).
  3. Any person qualified to stand for election under Clause (C) of Section 3(1) of the Act ibid may obtain nomination papers in form No.1 from the office of the Returning Officer (MCI Election-2015), ~~Indira Gandhi Medical College~~, Shimla (HP) w.e.f. 16<sup>th</sup> September, 2015, between 10:00 to 5:00PM on working day (other than Public Holiday).
- Each nomination paper shall be subscribed by two electors as proposer and seconder:

Provided that no elector shall subscribe more nominations than one


Provided further that if more than one nomination paper is subscribed by the same elector, the nomination paper first received by the Returning Officer shall, if otherwise in order, be held to be valid and if more than one nomination paper signed by the same elector are received simultaneously by the Returning Officer, all such nomination papers shall be held to be invalid (see Rule 12).

5. Nomination papers may be delivered by a candidate or by his proposer and seconder to the Returning Officer (MCI Election-2015), IGMC, Shimla between 10:00 Am to 5:00PM on any day (other than public holiday) not later than the 1<sup>st</sup> October, 2015. The nomination papers received after fixed date, time and place shall be rejected (See Rule 13).
6. The nomination papers will be taken up for scrutiny at 11:00AM on 5<sup>th</sup> October, 2015 in Room No. 601, Lecturer Theatre, 6<sup>th</sup> floor, Indira Gandhi Medical College, Shimla(HP). The Candidates and the proposer and seconder of each candidate may attend the office of the Returning Officer for scrutiny (See Rule 14).
7. Any candidate may withdraw his candidature within seven days after the scrutiny of nomination papers by notice in writing signed by him and delivered to the Returning Officer before 4:00PM on 13<sup>th</sup> October, 2015 (See Rule 15) .
8. A letter of intimation in form No. IV together with a numbered declaration paper in Form No. III, voting paper in Form No. II, containing the names of the candidates and bearing the Returning Officer's initials or facsimile signature, a voting paper cover addressed to him (Returning Officer) and an outer cover also addressed to him (Returning Officer) shall be sent to each elector for poll by the Returning Officer(See Rule 16).
9. Every elector desirous of recording his vote shall, after filling up the declaration paper and the voting paper according to the directions given in the letter of intimation, enclose the voting paper in the voting paper cover, stick up the cover, enclose the cover and the declaration paper in the outer envelope addressed to the Returning Officer, and send the outer envelope by registered post at his/her own cost to the Returning Officer, MCI election-2015, IGMC, Shimla or delivers it in person in the office of the Returning Officer, so as to reach him not later than 5:00PM on 28<sup>th</sup> October, 2015. All envelopes received after appointed date, time and place or received by unregistered post shall be rejected(See Rule 17).
10. The envelope containing the declaration paper and the closed cover containing the voting paper shall be received in the office of the Returning Officer (MCI Election-2015), IGMC, Shimla on or before 28<sup>th</sup> October, 2015 up-to 5:00PM. No envelope(s) shall be entertained thereafter in any manner whatsoever(See Rule 18).

11. The Outer envelopes shall be opened immediately after 5PM on the day of poll i.e. 28<sup>th</sup> October, 2015 in Room No. 601, Indira Gandhi Medical College, Shimla (HP). Any candidate may be present in person or may send a representative duly authorized by him in writing to attend at the time the outer envelopes are opened(See Rule 19).
12. All the voting paper covers, other than those rejected under Rule 20, shall be opened and the voting paper shall then be scrutinized and the valid votes counted on 31<sup>st</sup> October, 2015 at 11:00AM in Lecturer Theatre, Room No. 601, Indira Gandhi Medical College, Shimla (HP). Any candidate may be present in person or may send a representative duly authorized by him in writing to watch the process of counting. The Returning Officer shall show the voting papers if requested by the candidate(See Rule 21).
13. The Result shall be declared on 31<sup>st</sup> October, 2015 after counting of votes(See Rule 22).


