TERMS & CONDITION OF APPOINTMENT

1. Candidate should possess a Bachelor Degree or its equivalent from recognized University and Degree/Diploma in Library sciences from recognized University or an institution recognized by the Government of HP.
2. Candidate should be between 18 and 45 years in age.
3. The selected candidate shall be paid Rs.13500/-PM as consolidated remuneration i.e. Rs.10300+3200 grade pay and no other allowances shall be admissible there upon.
4. The contract shall be for a period of one year, extendable for another one year subject to satisfactory performance of work & conduct or till the post is filled upon regular basis.
5. No TA/DA shall be paid for walk-in-interview.
6. The candidate should also have the knowledge of customs, manners and dialects of Himachal Pradesh and suitability for appointment in peculiar conditions prevailing in the Pradesh.
7. The appointee shall have to work in shifts as per the requirement and duty roaster framed by the Incharge library.
8. The appointee shall not confer right to the official for any claim for regularization of his/her services.
9. The appointee shall not be entitled to claim any benefit for contractual services rendered with the department.
10. One day casual leave would be allowed to the contractual appointee after putting one month services.
11. In case the contractual appointee remains absent from duties the remuneration for the said period shall not be paid at all.
12. The appointee shall be terminated at any time in case his/her work and conduct is not found satisfactory.
13. The appointee may leave the contract by giving one month notice or depositing one month remuneration in lieu of the notice.
14. The appointee shall be liable to be terminated by the Chairman RKS without giving any notice if the contractual employee prima facie is found guilty of any in subordination, moral turpitude or other misconduct or of any breach of terms & conditions of appointment.
15. The candidate shall have to produce original documents alongwith photo copies of his/her educational qualification/degree/diploma etc. at the time of interview.
16. The appointee should be permanent resident of Himachal Pradesh.
17. The appointee shall have to submit bond amounting to Rs.5000/-(Rs. five thousand only) on a stamp paper worth Rs.5/- at the time of joining.
