

PROCEEDINGS OF THE PRE BID CONFERENCE HELD ON 13/02/2017 after 10.30 A.M onwards UNDER THE CHAIRPERSONSHIP OF DR. MADHU CHAUDHARY, ADDITIONAL DIRECTOR (Admn.) REGARDING SANITATION, SECURITY & WARD ATTENDANTS SERVICES OF DRPGMC & HOSPITAL, KANGRA AT TANDA

First of all, the Chairperson welcomed the members of the committee of the pre bid conference and representative of the firm mentioned ibid. Thereafter, the representatives from the firm were requested to put forth their queries/ suggestions, if any, regarding the tender document for Sanitation, Security and Ward Attendants of the DrRPGMC, Kangra at Tanda.

**Point No. 1:-** During the course of discussion the representative of M/S A2Z Infrservices Ltd., Gurgaon requested for the removal of clause appearing at page no. 9 at (2.d) under head 'Experience of the tender document for Sanitation' and suggested that that the instead of 500 bedded hospital, the similar work in civil/public sector may be considered. Similarly, the representative of M/S R.K & Company, Hamirpur requested that the condition of 500 bedded may not be changed.

The point raised by the firms was discussed at length in the meeting and it was decided by the committee that the existing tender condition would prevail regarding clause appearing at page no. 9 at (2.d) under head Experience, as no other representatives of firms has any query regarding the clause of experience in the tender document of sanitation.

**Point No. 2** The representative of M/S R.K & Company requested that the parameters fixed for the turnover and manpower may be revised as these parameter are very much stringent for providing the Sanitation Services.

The committee discussed the said parameters and it was decided by the committee that that the existing tender condition would prevail regarding the clause no.9.2.2 (ii) and (iii) in order to have quality services.

**Point No. 3** The representative of M/S R.K & Company requested that the experience 300 bedded hospital required for security & ward Attendants may be changed to 500 bedded hospital and the experience of continuous 5 years may be curtailed to 3 years in the tender of security.


The committee discussed the said points and it was decided by the committee that the existing tender condition would prevail regarding clause of experience in the tender of security and ward attendants.


Further, the committee requested the representatives of various firms that the minimum requirement as per tender document may be flagged and proper indexing of the technical bid may be done.

The participant firms were apprised that the proceedings of the pre-bid meeting will be communicated to them through the official website of DRPGMC, Tanda. The tender for providing sanitation, Security and ward attendants at Dr.RPGMC, Kangra at Tanda will be opened on 22/02/2017 after 11.00 A.M onwards.
