First of all, the Chairperson welcomed the members of the committee of the pre bid conference and representative of the firm mentioned ibid. Thereafter, the representatives from the firm were requested to put forth their queries/ suggestions, if any, regarding the tender document for housekeeping and security services of the DrRPGMC, Kangra at Tanda.

Point No. 1:- During the course of discussion the firms put forth their suggestion regarding removal of clause appeared at page no. 9 at (2.A) under head legal entity of the tender document and suggested that that the clause be amended so that proprietorship and partnership firms may also be allowed to participate in the tender process.

The point raised by the firms was discussed at length in the meeting and the committee after due deliberation resolved to relax the said clause to the extent that the proprietorship and partnership firms are also permitted to participate in the tender process so that there is maximum participation of the firms for better competition.

Point No. 2 All the firms requested to separate the tender into two parts i.e one Housekeeping and two Security so that two different tenders may be quoted by the firms.

The committee discussed the said point and keeping in view the Govt. directions and also healthy competition in the recent tender which is under process for the Super Specialty Block, it was decided that the existing tender condition would prevail.

Point No.3 During the course of discussion the firms requested to specify the critical areas i.e ICU etc. of the hospital and also specified the numbers of the machinery, Chemicals and consumables.


In context of above point the detail of ICU's are as under:

1. Block No. 5 (2No. ICU) = 193 sq. mtr (approx.).
2. Block No.6 (1No. ICU) = 36 sq. mtr (approx.)
3. Block No. 7 (1 No. ICU) = 144 sq. mtr (approx.)

Further, It was conveyed to the firms that the number of machinery and brands of the chemical and consumable has been clearly mentioned in the tender document.

The participant firms were apprised that the proceedings of the pre-bid meeting will be communicated to them through the official website of DRPGMC, Tanda. The tender for providing Housekeeping and Security Services of Dr.RPGMC, Kangra at Tanda will be opened on 20/07/2015 at 2.30 P.M.
