NOTICE FOR EXTENDED MOP UP ROUND OF CENTRALIZED COUNSELING TO FILL-UP VACANT /UNFILLED PG(MD/MS) SEATS IN GOVERNMENT MEDICAL COLLEGES OF THE STATE FOR THE ACADEMIC SESSION 2020-21.

Union of India & Others has extended the last date for PG(MD/MS) admission 2020-21 up to **31.8.2020**, therefore, in order to fill-up the vacant /unfilled PG(MD/MS) seats in Govt. Medical Colleges of the State, the extended Mop-up round of Centralized Counselling is to be conducted on **28.8.2020 at 10:30 AM** at Atal Sabhagar, Auditorium, Indira Gandhi Medical College, Shimla by offline mode. Those candidates who have already opted the PG(MD/MS) Courses seats at IGMC, Shimla and Dr. RPGMC, Kangra at Tanda, (State Quota)if they intend to participate in the extended Mop-up round of Counselling are required to surrender the PG Degree seat previously allotted to them on or before **26.8.2020 till 2:00 PM** through e-mail scanned PDF copy of resignation letter addressed to Principal IGMC, Shimla i.e. **pgigmc@gmail.com** using their registered e-mail only. In case such candidate will not opt for any seat during the Extended Mop up round, then his/her fees as deposited earlier will be forfeited. The final seat matrix will be uploaded on the official website of IGMC, Shimla on **27.8.2020**.

The candidates who have admitted to PG Degree Courses under 50% All India Quota are not eligible to participate in the Extended Mop-up round of Counselling.

The desirous candidates are hereby directed to report for Counselling personally or through their authorized (one) representative on **28.8.2020 at 10:30 AM** along with Original Certificates, admission fee amounting to **Rs. 39000/-** or (Original proof of deposition of certificates in IGMC, Shimla and Dr. RPGMC, Kangra at Tanda) and one complete set of required certificates/documents (photocopies) as per PG Prospectus-2020-21, failing which their candidature will not be considered. All the seats will be filled up in order of merit and 40 point reservation roster. Application of 40 point reservation roster is a continuous process and since during the Mop-up round of Counselling the roster point was exhausted at point No. **32** and it will start from roster point number **33**.

The entire process of Centralized Counselling, seat allocation and admission will be done physically and admission will be provisional subject to the Medical fitness and deposition of all relevant documents.

Only the candidate/representative alone will be allowed to enter in the Auditorium due to COVID-19 precautions.
