6. Date and time of opening of tender 12.10.2020 at 3:00 PM
7. Place of opening the tender Administrative Block of Dr. R. P. Govt. Medical College, Kangra at Tanda.
8. Terms & conditions
 - a) Rate The rate should be quoted in sealed envelope on "As is where is" basis as per **Annexure "B"** attached. The rate should be written both in figures and words. In case of difference, the rate mentioned in words will be considered. Any condition or counter condition given by the bidder shall not be acceptable to the institution and conditional bid is liable to be rejected.
 - b) Detail of condemned articles The articles to be sold have been divided into five categories. These categories are "**C.G.I Sheet, Channel (Two Type), Angle & Steel**". The detail of Dismantled Material/Scrap have been mentioned in the format attached herewith as **Annexure-A**. The bidder will have to quote rate separately for each category/item and Grand total of all items in **Annexure- B**.

- c) Reserve Price/Govt. Rate The bid money offered below the reserve price will not be entertained.
- d) Opening of Bids Bids will be opened as per the above mentioned schedule. The bidders, if interested may be present during bid opening process and only one representative from one firm will be allowed.
- e) Award of Tender The tender will be awarded to the H1 bidder only.
- f) Bid Security DD for an amount of Rs. 25,000/- in favour of "**Medical Superintendent-cum-Member Secretary, RKS, Dr. R. P. Govt. Medical College & Hospital, Kangra at Tanda**" to be attached with the tender otherwise tender is liable to be rejected. The bid security money will be returned to the unsuccessful bidders after the finalization of contract and in case of successful bidder it will be adjusted against the contract value. This bid security money does not carry any interest
- g) Quality & quantity The condemned items will have to be lifted by the successful bidder on "As is where is basis". The department will not be responsible for giving the material by measurement etc. No claim whatsoever regarding quality, quantity, measurement shall be entertained.
- h) Payment Full payment on account of bid money in the shape of DD is to be deposited within five days from the date of issue of bid acceptance letter.
The DD is to be in favour of "**Medical Superintendent-Cum-Member Secretary, RKS , Dr. R.P. Govt. Medical College & Hospital, Kangra at Tanda**". In case of non deposit of full bid money within the stipulated period, the bid security money deposited will be forfeited.
- i) Penalty Clause After receiving the full bid security money, sale release orders will be issued by this office. The successful bidder will have to lift the sold material within seven days from the date of issue of sale release order failing which penalty @ Rs. 1000/- per day will be imposed after stipulated period.
- j) Cancellation of Tender If the dismantled material/scrap is not lifted within 7 working days even after imposing penalty clause, the

award of contract will be cancelled and may be offered to other competitive bidder and deposited earnest money will be forfeited.

- k) Taxes All statutory levies if any will be borne by the successful bidder.
- l) Dispute Institution reserves the right to reject any/all tenders without assigning any reason. In case of any dispute, the decision of Principal Dr. R.P.GMC Kangra at Tanda will be final and binding.
- m) Labour/Tools Labour charges and other expenses for lifting the all types of Dismantled Material/scrap will be in the scope of the bidder. Carriage, lifting and loading in the truck will be borne by the bidder.
- n) Safety Bidder is responsible for any miss-happening if any with their engaged labour during the operation of lifting all types of Dismantled Material/scrap.
