On the subject cited above, it is to inform you that as per notice issued by the Government of India , Directorate General of Health Services, Nirman Bhavan, New Delhi vide Ref. No. U12021/25/2021-MEC dated 15.01.2021, the academic session 2020-21 for 1<sup>st</sup> year MBBS/BDS course is to be started from 02.02.2021 .

You are directed to issue necessary notice in this regard on college notice board and college website for wide publicity amongst the students who have been admitted for 1<sup>st</sup> year MBBS/BDS course during the academic session 2020-21 . As decided earlier, all the students be directed to strictly comply with the following directions:-


- I. A self health undertaking regarding risks involved (as submitted by students of other States) should be taken from the students at the time of joining college/hostel counter-signed by the parent/guardian.
- II. Parent consent/No objection form duly signed by the parent/ guardian need to be submitted before joining.
- III. Negative COVID-19 test received in the last 72 hours need to be submitted before joining.
- IV. The SOPs/ guidelines issued by Central/State governments regarding COVID-19 so that proper staggering/social distancing, using of masks and sanitizing the college/hostel premises will be followed scrupulously. For this

purpose a committee under the Chairmanship of hostel warden shall be constituted which will implement and monitor the directions given to prevent the occurrence/spread COVID-19 infection amongst students and other staff members.


- V. That in case 2 to 3 students are staying together, the above said Committee will test them randomly after every two weeks or so.
