

- b) It is compulsory to bring all the original applications during at the time of joining.
- c) No TA/DA will be paid to the candidate for appearing for examination and joining.
- d) Terms: Posts are purely temporary. Appointments will be initially for a period of 89 days and may be extended further based on the tenure of the Project. However, the appointment can be terminated at any time even before the end of the contract period due to any reason. In case of such premature termination, one month's notice or one month's salary in lieu of the same will be provided. The same will not hold true in case of premature termination due to performance related issues. Candidate can leave the job prematurely giving one month's notice or one month's salary in lieu of the same.

- If local persons are not available, the persons from the adjoining area will be considered.
