Terms and condition are as under:


1. The offer should be accompanied with EMD worth of Rs,20,000/- (Rs. Twenty thousand only) in the shape of FDR duly pledged in the name of the undersigned. The EMD of successful bidder should be retained in the office of undersigned as security money and in the case of any violation of term and conditions same should be stand forfeited. The limiter tender without earnest money or short or not in form specified above will be rejected straightway.
2. The non- refundable document will be sold at counter on payment of limiter tender fee of Rs.500/- (Rupees five hundred only ) through cash.
3. The lowest quoted rate will considered.
4. Non Blacklisting Certificate: All the bidders will give an undertaking on non judicial Stamp paper of Rs.10/- duly attested by the Rotary.
5. Medical Superintendent-cum-Member Secretary RKS reserves the right to accept or reject any or all the limited tender without assigning any reason, at any stage and without incurring any obligation to inform the affected applicants.
6. Copy of GST/CST/VAT of self attested.
7. Copy of PAN No duly self attested.
8. Copy of Bank account pass book
9. Rate should be quoted in prescribed Performa or letter pad as per annexed "A"
10. That rate contract shall initially for a period of one year and can be extended by one year on mutual consent.
11. That the rates quoted ,should be F.O.R and inclusive of parking ,forwarding ,insurance, freight etc. The rates should be quoted in Indian currency only.
12. That the time for delivery/dispatch, stipulated in the supply order shall be deemed to be the essence of the contract. The supplier will not be paid for the supplies rejected and shall have to carry out full replacement immediately or as specified. This
