

ii. It is compulsory to bring all the original applications during at the time of joining.

iii. No TA/DA will be paid to the candidate for appearing for examination and joining.

iv. Terms: Posts are purely temporary. Appointments will be initially for a period of 30 days and may be extended further based on the tenure of the Project. However, the appointment can be terminated at any time even before the end of the contract period due to unsatisfactory work. In case of such premature termination, one

2. Essential Qualifications:


- i. Qualifications and degree should be from recognized Institution/ University.

3. Desirable criteria:

- i. Candidate belonging to the local area will be preferred.
- ii. If local persons are not available, the persons from the adjoining area will be considered.
