Terms & Conditions

1. They will not be entitled for stipend.
2. They will have to deposit **Rs.1,92,000/- (rupees one lakh ninty two thousands only) for one year** as per the revised Governing body (RKS) rates vide letter No. HFW-H(DRPGMC)General- 3934-36 dated 18.2.2022 .
3. They will have to produce a copy of certificate qualifying the final Prof. MBBS exam. from the concerned college which should be recognized by the NMC/GOI.
4. They will have to produce NOC from the concerned College.
5. They will have to produce a copy of provisional registration certificate of HP Medical Council at the time of joining internship.
6. The hostel accommodation will be provided only if available.
7. They will have to undergo Internship Training Programme accordingly as per the NMC schedule.
8. This Institution is recognized by the Govt. of India vide letter No.U.12012/65/96- ME(P-II) dated 24.2.2005.
9. The Elective Posting will be allowed only in the department of Chest & TB.
10. They will abide by all the directions of the Govt. in relation to COVID-19 and before joining they will complete all the modules on Diksha app pertaining to COVID.
11. They will download Arogya Setu app.

The above selected Candidates will have to deposit the internship fee as mentioned above within 7 days from the date of issuing this letter and subsequently they will get registered with H.P.Medical Council before joining the internship , failing which seat will be allotted to the next candidate in merit accordingly.
